- 2. Sec: 3:01 (v) and Sec: 4.03 (f) Removal of voting of past president, this position is automatically filled with the election of a new president.
- 3. Sec: 3.03 (d) (i)Changes regarding subcommittee creation, (ii) Responsible for enforcement of playschool handbook, and (iv) Added provide finances for annual financial review
- 4. Sec: 3.03 (g) (v) Ability appoint a standing subcommittee to assist in the position
- 5. Sec: 3.03 (h) (i) Changes to include Soccer Director in additional directors to work with to fulfill volunteers.
- 6. Sec:3.03 (j) (ii) Add fundraising and (iii) Add ability to appoint sub committees
- 7. Sec: 3.04 (d)(iii)Addition of requirement for standing committees to have a board approved "terms of reference"
- 8. Sec: 5.01 (b) (vi)(vii)Addition of Playschool teacher and playschool co-teacher to list of restricted key access
